Solution: We first have the 21 consonants arranged arbitrarily and there are 21! ways to do so. For each





such 21- permutation, we arrange the 5 vowels a,e,i,o,u in 22 positions between consonants; there are P (22, 5) ways of such arrangement. Thus in 21! x P(22,5) =21! 22! /17! Ways we can arrange the 26 alphabets so that no two of the vowels a, e, i, o, and u occur next to each other.

Solution:

Assume the number of oranges is A. Then A-1 is divisible by 3, 5, 7 and 9. So, A-1 is a multiple of $5 \times 7 \times 9 = 315$ (note: 9 is also a multiple of 3, so 3 must not be included!). We are looking for a value of N for which holds that $315 \times N + 1$ is divisible by 11.

After some trying it turns out that N = 3. This means that the greengrocer has 946 oranges.
